DROP BOX LOCATIONS

Please include the following with your payment:

Parcel number on your check
Payment stub of your tax bill
Endorse the back of your escrow check
Self-addressed, stamped envelope for receipt

REFUNDS

If your escrow check exceeds the amount of your tax bill, you will be issued a refund check within 30 days of payment.

RECEIPTS

For a receipt by mail, enclose a self-addressed, stamped business-sized envelope along with your tax bill and payment. A receipt will **NOT** be provided unless a self-addressed, stamped envelope is included. Receipts will also be available online within 30 days on the Dane County Treasurer's website:

E-CHECK AND CREDIT CARD PAYMENTS

E-Check payments can be processed online through our website www.cityofsunprairie.com. FIS charges a \$1.00 fee for this service.

Credit card payments can be processed online through January 31st on our website www.cityofsunprairie.com. FIS charges a fee equal to 2.35% of the amount of the payment.

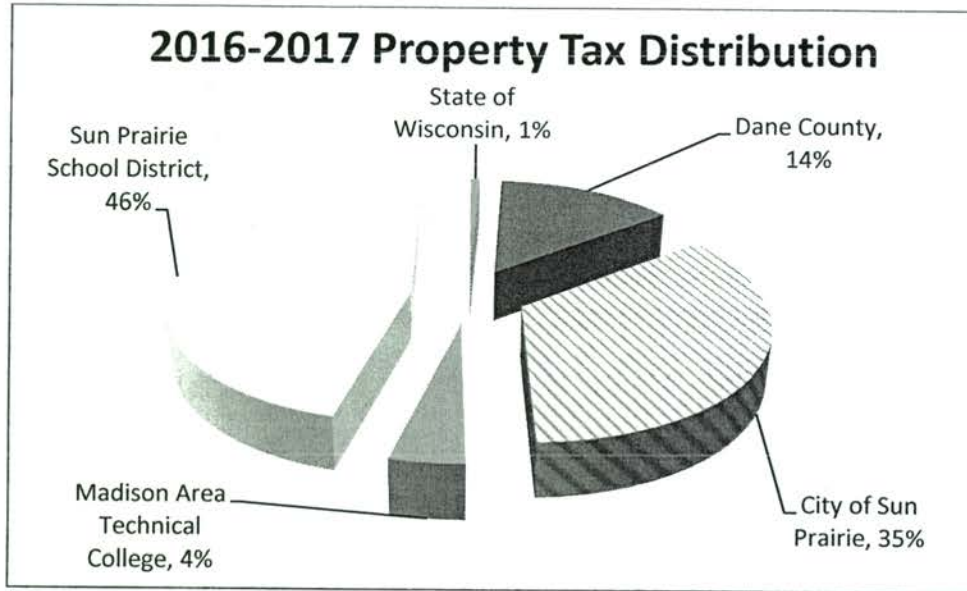
DID YOU RECEIVE YOUR LOTTERY & GAMING CREDIT?

If you do not have a Lottery & Gaming credit on your tax bill you may still be eligible!

To Qualify: Your home must have been the PRIMARY residence for you or the previous owner on January 1, 2016. *If you feel you qualify for the Lottery Credit:* You may obtain the Lottery Credit Claim Form on our website, www.cityofsunprairie.com (Finance Department: Property Taxes Section), contact the Treasurer's Office at 300 East Main Street, or call 608-825-1192, prior to January 31, 2017.

AM I ELIGIBLE FOR THE FIRST DOLLAR CREDIT?

If your real estate bill has an “assessed value improvement” amount, the credit should automatically show on your bill. Anyone entitled to the credit that does not receive it must appeal directly to the Wisconsin Department of Revenue.
