RESOLUTION

WHEREAS, the City placed out for bid Contract 226040 for the STH 19 and Grand Avenue intersection and Grand Avenue and Blue Heron Boulevard intersection improvements project; and

WHEREAS, on Tuesday, April 12, 2022 the Public Works Committee met to review the award of Contract 226040; and

WHEREAS, bids were received from three Vendors, with the low bid from Lalonde Contractors, Inc. with a bid of \$1,772,174.44; and

WHEREAS, upon review of the bids, staff recommended and Public Works Committee approved the award of Contract 226040 to Lalonde Contractors, Inc. for the STH 19 and Grand Avenue intersection and Grand Avenue and Blue Heron Boulevard intersection improvements project; and

WHEREAS, during the bidding process it was determined that a budget amendment for \$553,987 would be needed; and

WHEREAS, the budget amendment is as follows:

Increase Capital Projects – Streets	\$552,137.00
Increase Sanitary Sewer Capital Projects	\$ 1,850.00
Increase Proceeds of Notes	\$175,786.00
Increase Intergovernmental Revenue	\$376,351.00
Increase Sanitary Sewer Fund Balance Applied	\$ 1,850.00

WHEREAS, upon review of staff recommendations for award for contract, the Public Works Committee voted 5-0 to recommend the approval of this budget amendment on April 12, 2022.

NOW, THEREFORE, BE IT RESOLVED that the Common Council of the City of Sun Prairie, Dane County, Wisconsin, hereby approves the budget amendment in the amount of \$553,987 for the changes to the STH 19 and Grand Avenue intersection and Grand Avenue and Blue Heron Boulevard intersection improvements project.

NOW, THEREFORE, BE IT FURTHER RESOLVED, that the Common Council of the City of Sun Prairie, Dane County, Wisconsin, hereby approves Contract 226040 for STH 19 and Grand Avenue intersection and Grand Avenue and Blue Heron Boulevard intersection improvements project.
