## State of Wisconsin Credits

### **Lottery & Gaming, First Dollar**

To qualify for Lottery & Gaming Credit, your home must be the primary residence for you, or previous owner, on January 1, 2025.

Verify you received your Lottery & Gaming Credit on your 2025 tax bill.

- **If you did not receive credit and qualify**, complete the form through the online link below or come into City Hall with LC-100 **BEFORE January 31, 2026.**

**Payment Information**

**Check Payments**

- Make checks payable to:  
**City of Sun Prairie Treasurer**
- Write parcel number on your check
- Please write current phone number
- Include payment stub from the tax bill in your envelope.

**NOTE:** If an escrow check has multiple names on “Payable to” line, including the word “AND”, all parties **must** endorse the back of check to ensure timely payment.

- Example – If check is Payable to:  
**City of Sun Prairie and JJ Sunny and CC Sunny.** Both JJ and CC need to endorse the check, before sending it to City of Sun Prairie.

**Drop Box Locations**

**City Hall Police Department Lobby**  
Green drop box is through the first set of doors of City Hall building, 300 E Main St. Enter through the Main Street entrance.

**Westside Community Service Building**  
Drop box slot is inside the first set of doors by the parking lot, 2598 W Main St.

**Payments after 1/31/26 and 2<sup>nd</sup> installment payments must be sent to Dane County Treasurer.**

**Electronic Payments**

E-checks and credit/debit card will be accepted until 4:00 pm CST, Monday, **January 27<sup>th</sup>**, 2026, whether made online or in-person. Payments after this date must be made either via check or cash.

**Timing on Payments**

For those wishing to complete payment in 2025, payment must be postmarked or in drop boxes by **12/31/25.**

**Deadline for electronic payments is 4:00 pm on 1/27/26.**

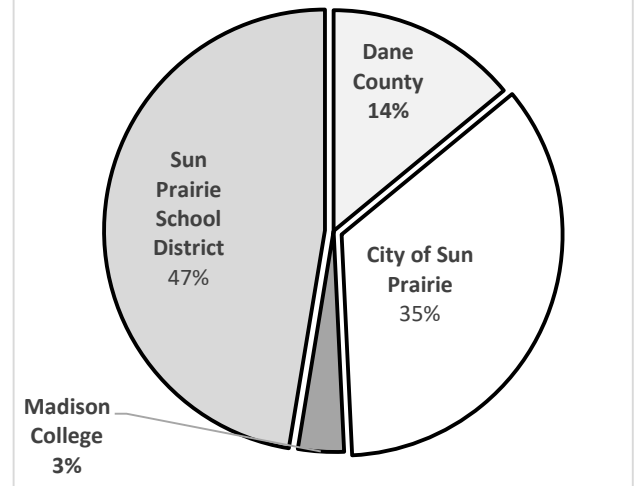
**Refunds**

If payment exceeds full amount due, a refund check will be issued to the name(s) and address on tax bill, in approximately four weeks.

**Receipts**
