

## USE CAUTION!

**Hazardous products have warning labels for a reason.**

**Before transporting them in your vehicle, take the following precautions:**

Keep products in their original containers, when possible.

Make sure products are properly sealed to prevent leaks and spills.

If a container is leaking or unstable, you will need to use a secondary, leak-proof container.

Do not mix products together. Dangerous reactions can occur when some chemicals are mixed.

Pack containers in a sturdy box in the trunk of your vehicle. Keep away from the driver, passengers and pets.

Boxes and containers (other than gasoline cans) cannot be returned to you.

Please do not put items in plastic bags.

If a product does not have the original label, label it yourself if you are certain of the contents. This will help us dispose of it properly.

Always store products in a secure place, away from children, pets, sparks and flames.

Latex paint is not a hazardous material. To properly dispose of latex paint, follow these simple instructions:

1. Open the can.
2. Dry or solidify the paint by mixing with Floor Dry, cat litter or sawdust. If the can is full, you will need to use a secondary container.
3. Dispose of the can and solidified paint in your refuse cart. Please remove lid.
